The Tuscowilla Art Park is a key component of the Tuscowilla Park Master Plan complimenting existing cultural investments including the Discovery Center, the repurposing of the City Auditorium as the Reilly Arts Center - home to the Ocala Symphony Orchestra, the annual Ocala Outdoor Sculpture Competition, and the future Art Depot Studios at Union Station.

4b (Code: ) (Expenses \$ 51,000. including grants of \$ 51,000.) (Revenue \$ ) Mrs. Angela Muns, a United States Airforce Lt. Colonel, was a registered nurse who served during World War II. Her love of her military service and of her chosen profession led to the establishment of a nursing scholarship to ensure that those wanting to excel in the field of nursing had the opportunity to obtain a nursing degree.

Mrs. Muns and her husband had both received excellent healthcare in Ocala/Marion County. This scholarship trust was established in recognition of the exceptional care they received. The legacy scholarships not only enable students to pursue nursing degrees but post-graduation, the trust stipulates that they continue their career in an acute healthcare facility for up to an additional two years.

The ARC Marion Foundation, Inc. was an organization established to philanthropically support ARC Marion Inc. and its programming that improves the care and training of individuals with developmental and/or intellectual disabilities in Ocala/Marion County. Upon their dissolution in 2014, the board of directors of ARC Marion Foundation established Scholarships to be administered in by the Community Foundation of Ocala/Marion County for the direct needs of individuals with intellectual and/or developmental disabilities at ARC Marion Inc. As of the end of 2017, the Community Foundation has administered \$113,403 in total awards.
