A NEW HOME FOR NONPROFITS

With the help of Nonprofit Resource Center partners, we moved into the "brick building on the hill" in early 2019. At 324 SE 24th Street just off Pine Ave/US 441, we are centrally located to benefit nonprofits across the community with services and resources needed to grow their capacity and sustainability. In 2019, we offered Grant Services to dozens of nonprofits, many of whom had never received grant awards, and some who had never completed a grant application before. In just six months, we helped bring in more than \$2.5 million in new grant dollars to community nonprofits. We rounded out the year forging partnerships to kick-off 2020 with many new programs and opportunities for nonprofits. From professional development and strategic planning services to finance and accounting counseling and camera-phone video coaching, our nonprofits will have access to more resources than ever before.

We established a record-breaking 11 new funds.

We welcomed five new members to the Board of Directors with remarkable credentials and a depth of knowledge and experience in philanthropy.
