1 CALCULATE PAYROLL COSTS



2 CALL YOUR BANK

Ask if they are a Small Business Administration Lender. If they are, you can apply for a Paycheck Protection Program Loan through your bank.

3 IF YOUR BANK IS NOT AN SBA LENDER,

*call the Community Foundation for a
trusted recommendation.*

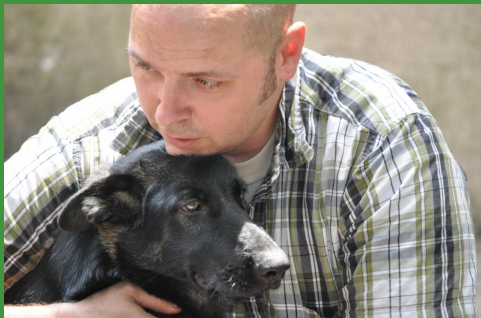


4 ENTER THE QUEUE

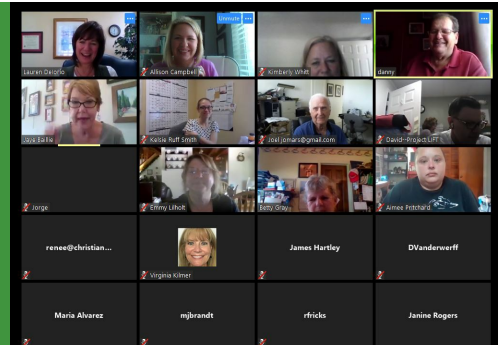
*Ask the lender to put your organization in

5 FUNDING WILL BE DISBURSED

*Ask your lender for more information
on timing and turnaround.*
