Nomination Criteria by Category

Youth Philanthropist of the Year

- Nomination can come from a teacher, administrator, guidance counselor, coach, or school board member
- Nominee must have completed Adam Hanson Youth Philanthropy in Action program
- Nominee must be in grade 7 through 12 during the current school year
- Nomination requires an example of an act(s) of philanthropy, volunteer work, and being a role model for other students

Emerging Nonprofit

- Nomination can come from any community member within Marion County
- Nonprofit must be under five (5) years old as of January 15, 2026
- Nomination requires the nominee to have an active board or committee, serving in Marion County
- Nomination requires an example of how this nonprofit has fulfilled a need in the community

Nonprofit Board Member of the Year

- Nomination must come from a Nonprofit or fellow board member
- Nominee must have completed one (1) year or more with the nominating nonprofit
- Nomination requires an example of an act(s) of philanthropy, volunteer work, or board commitment to help the nonprofit and the members it serves better

Nonprofit of the Year

- Nomination can come from anyone in the community that has volunteered, sat on the nominee's board, received services from the nominee, or donated to the nominee
- Describe the nominee's community efforts, programs, and how they support the community on a daily basis
- Describe the nominee's greatest impact in the community
- Nomination requires an example of who the nonprofit serves within the community

Corporate Partner of the Year

- Nomination can come from anyone in the community that has witnessed or experienced partnership
- Describe the nominee's volunteer efforts, include which nonprofit(s) or community programs and initiatives the nominee has volunteered with, which individuals and groups they supported, and their length of service
- Describe the impact or value the nominee's volunteer service has made to the community
- Did the nominee begin a new program, solve a community problem, or initiate creative ways tow ork with an organization? If so, explain.
- Describe how the nominee creates a culture of community engagement.

The Unsung Hero

- Nomination must come from a nonprofit, board member, or fellow volunteer
- Describe the nominee's volunteer efforts, include which nonprofit(s) or community programs and initiatives the nominee has volunteered with, which individuals and groups they supported, and their length of service
- Describe, and give detailed examples of, the impact or value the nominee's volunteer service has made to the community

Philanthropist of the Year

- Nomination can come from anyone in the community that has witnessed or experienced the work of the nominee
- The nominee can be an individual or family
- Describe the nominee's volunteer efforts, include which nonprofit(s) or community programs and initiatives the nominee has volunteered with, which individuals and groups they supported, and their length of service
- Describe the impact and value the nominee has brought to our local community by volunteering, serving on a board, or creating community programs through one or more nonprofits
